This course in Research Methods in Economics prepares students with essential skills and knowledge needed to conduct demanding and effective economics research. Via a combination of theoretical concepts and real-world applications, students will learn how to structure research projects, collect and analyze data, and communicate research findings within the context of economics

Expectations and Goals

- I. Frame clear and relevant research questions in the field of economics.
- II. Select applicable research approaches for different types of economic research questions.
- III. Collect, process, and analyze economic data using quantitative and qualitative techniques.
- IV. Interpret and communicate research findings effectively within written reports and presentations.
- V. Understand the implications of economic research for policy and decision-making.
