Attendance Policy

Evaluation Criteria (SRCA)

Each Student will be evaluated based on the following criteria's:

Final Exam – 40 marks

OSCE

Narratives, attendance & clinical case discussion – 60 marks Narratives & attendance scoring [(4 marks/day X 15 weeks = 60 marks)] + Overall improvement should be achieved as mentioned below.

Narratives should be based on the following criteria:

- Scene size-up
- MOI/NOI
- General Impression [Age, sex etc.]
- Chief Complaints
- Vital Signs
- SAMPLE History
- OPQRST History
- Field Impression (diagnosis)
- Treatment (IV, Medications, airway management, ...elt)
- Reassessment
- At least one case on each shift. If there were no patients; then students should arrange another shift, and complete the requirements (to be within the same week).
- Daily attendance sheet and skills performed should match with each other.
- 4 days & more absence repeat the whole course, based on university rule of 25% absence.
- **Sick leave** from KKUH or governmental health organization only (to be submitted within 1 week) and students has to make for the **miss** clinical practice by attending other day.



Clinical case discussion scouring [Maximum 8 marks to ensure quality improvement and no improvement minimum zero marks]

Clinical case discussion meeting:

- Attendance is mandatory (if not showing up, absence will be counted) 4
 days & more absence repeat the whole course, based on university rule
 of 25% absence.
- An academic instructor will be assigned for each group of students (please check the attached table to identify your group, place, time & date of meeting)

Check point of each student – every 2 weeks

- Their attendance
- Narratives feedback for improvement
