#### Personal Data Protection Law (PDPL)

- The PDPL is the primary data protection legislation in Turkey.
- It sets out principles, obligations, and rights concerning the processing of personal data.
- The law imposes requirements on data controllers and processors and provides individuals with privacy rights.



#### Personal Data Protection Act (PDPA)

- The PDPA is a data protection law in Singapore that governs the collection, use, and disclosure of personal data.
- It outlines obligations for organizations and provides individuals with rights over their personal information.



### Personal Information Protection Law (PIPL)

- The PIPL is a proposed data protection law in China that is expected to be enacted in the near future.
- It focuses on the protection of personal information and imposes obligations on organizations regarding data processing.



### **Privacy Shield**

- Privacy Shield was a framework established between the EU and the United States to enable the transfer of personal data between the two regions in compliance with the GDPR.
- However, the framework was invalidated by the Court of Justice of the European Union in 2020, and alternative mechanisms for data transfers are now being used.
